Integrated Ethics Conference examines Community Care Services

Midwest Health Care network gathered here for a two day conference January 20 and 21. The 42 leaders, program officers, ethics consultation coordinators and preventative ethics coordinators met at the network office to hear presentations on current issues, discuss

It was an honor for the Fargo VA to host the ceremony for Teah and her new husband, and we thank Mr. Frye for his service to the country.

The event was coordinated in conjunction with the Fargo VA's Wishes on Wings program. The focus of the Wishes on Wings program is to help Veterans fulfill a last wish with the limited time they have left.
